#### ADVERTISEMENT

Application in prescribed format are invited from the Citizens of India for filling up of 19 (nineteen) post of Steno Grade-III(Personal Assistant )under APSS (General Cadre) in the pay band of Rs.5200-20200/GP Rs.2800/- PM. Plus other allowances as admissible to the Arunachal Pradesh Govt. Employees from time to time. Out of 19 (nineteen)) posts, 3 (three) posts are Un-reserved and 16 (sixteen) are reserved for APST candidates. Out of 16(sixteen) posts, 1(one) post is reserved for Physically Handicapped candidate of one leg and one arm only. The vacancy position is subject to variation .

### 1. EDUCATIONAL QUALIFICATION:

Candidates applying for the post must have passed the Bachelor's Degree or equivalent from a recognized university.

## 2. **ELIGIBILITY**:

The candidates should not be less than 18 years of age and not more than 30 years of age as on <u>29.07.2016</u> The upper age limit is however, relaxable in accordance with the orders issued by the Govt. from time to time.

#### 3. METHOD OF RECRUITMENT:

Selection will be done on the basis of Stenography Speed Test of 80 words per minute followed by Written Competitive Examination on the following subjects:

(i)	General English (including essay writing)	100 Marks
(ii)	General Knowledge	100 Marks
(iii)	Speed Test-80 WPM (In stenography)	100 Marks
(iv)	Viva-Voce	40 Marks
	TOTAL =	340 Marks

Stenography Speed Test of 80 WPM will be conducted before the written examination. The candidates who qualify in the speed test will be called for written examination.

The candidates who secure a minimum of 33% or more marks in each written examination paper and 45% of marks out of aggregate total marks in the written examination papers shall be eligible for selection.

NOTE: The Commission will adopt Recruitment Test (Objective type) before the written examination if it is deemed necessary to do so.

#### 4. AVAILABILITY OF PRESCRIBED APPLICATION FORMAT:-

Applications Form for admission to recruitment examination to the post of Stenographer Grade-III (PA) can be obtained from the Commission's Office, Itanagar on all working days from 10.00 AM to 4.00 P.M. up to 29.07.2016 on cash payment of Rs.50/- only for APST candidate and Rs.80/- only for General candidate. No separate examination fee in the form of DD/Treasury Challan will be required along with the application. The examination fee has been included with the cost of application form.



Further, Application form & Attendance sheet can also be typed out or downloaded from Commission's website <a href="www.appsc.gov.in">www.appsc.gov.in</a>. and it can be sent through post enclosing required fee in the form of Demand Draft/IPO in favour of the Secretary, Arunachal Pradesh Public Service Commission, Itanagar . The envelope must superscribed on its body "Application form for the post of Stenographer Grade-III". Last date for receiving of application form for the post of Stenographer Grade-III is upto 29.07.2016.

# 5. HOW TO APPLY:

Along with the duly filled up application, candidate must enclose the following documents otherwise the application will be rejected.

- (i) 2(two) recent colour pass port size photographs duly attested by Gazetted Officer/Self Attested which should be pasted on the space provided in the Application form and attendance sheet respectively.
- (ii) Self Attested copy of Class-X passed certificate issued by the Recognized Board/University.
- (iii) Self Attested copy of Class-XII passed certificate issued by the Board only will be accepted.
- (iv) Self Attested copy of Bachelor's Degree Certificate.
- (v) Self Attested copy of APST Certificate.
- (vi) Self Attested PRC for General Candidate.
- (vii) Copy of NOC from concerned department (in case of candidate already in the Govt. Service).
- (viii) Duly Self Attested Disability certificate for person with disability from authorized Standing Medical Board.

The concerned specialist must be a member of such Standing Medical Board.

All the supporting documents submitted by the candidates must be Self Attested or by a Gazetted Officer with seal and signature of the attesting officer other wise the application will be rejected.
